

I understand and agree to the following:

1. Tuition is based on a yearly fee schedule, but may be paid monthly.
2. Tuition payments are due on the first of each month, September through May, and are considered delinquent if not paid by the 10th of each month. A \$20 late fee will be charged for each month a payment is delinquent. Recital Fees and Costume Fees have a 10 day grace period before \$20 late fee is incurred.
3. Tuition payments and all remaining fees (costume fees, late fees, etc.) must be current in order for student to participate in any Leap of Faith Dance performance or year-end program.
4. Be sure to note what you are paying for on the "check memo line" or "cash envelope".
5. If student needs to withdraw from classes, I am responsible for tuition in full until such time as the school office is notified.
6. I understand that Leap of Faith Dance reserves the right to cancel any class that does not have a sufficient number of students enrolled to support the class.

7. Class changes need to be put in writing and dropped in the tuition box.
8. Costumes are required for performances. (One per class). Costume fees are due Sept 19th and run about \$40 to \$85 per class. It is not required to perform. Costume fees are non-refundable.
9. Students agree to the "Classroom Attire" requirements.
10. Spring Recital fees are due Jan 9, 2012 and are non-refundable. First Student is \$40, second is \$30, family maximum of \$100.
11. Students with more than 6 absences will not be allowed to participate in the semester performance.
12. For every new student that you refer (and they begin taking classes at LOFD), you will receive a \$50 one time credit toward your tuition.
13. Private lessons are available and encouraged. Talk to Ms Sharon or Ms Addie for details.
14. We reserve the right to dismiss any student due to disciplinary/behavioral problems and no refund will be given.
15. All students must stay in the dance studio building until parent/guardian arrives to pick their child up. No standing outside the front door. We are not responsible for your child once they leave the building.
16. I consent to the use of any video images, photographs, audio recordings that may be taken of this student during any class or event at or for Leap of Faith Dance to be used distributed or shown as Leap of Faith Dance sees fit. This includes newspaper, website, TV commercials, etc.
17. By signing below, I do hereby release Leap of Faith Dance and their agents or representatives of liability for my child (or myself) of any injury to my child (or myself) in class, while on the school campus, or while participating in Leap of Faith Dance performances. I understand that in the event medical intervention is needed, every attempt will be made to contact the person(s) listed on the student's registration form. In the event next of kin cannot be contacted for the health and well being of my child (or myself), I hereby authorize the Principal or Instructor of Leap of Faith Dance to authorize whatever medical treatment that might be necessary in an emergency situation. I understand that I and my medical insurance carrier are financially responsible for any medical treatment extended to my child (or myself), and that Leap of Faith Dance and its agents or representatives cannot be held accountable or liable for such medical treatment.
